#### TOWN OF HASTINGS. OSWEGO COUNTY, NEW YORK ORGANIZATIONAL TOWN BOARD MEETING- JANUARY 9, 2024

### ATTENDANCE

The Town of Hastings Town Board held a regular meeting on Tuesday, January 10, 2023, at 7:30 PM. **Board members present:** Supervisor Tony Bush, Councilman John Hill, Councilman Mark Martino, Sr., Councilman Alan Hanson, and Councilman Richard Waldron.

**Also present:** Michael Lewis, Highway Superintendent; Jason Burns, Director of Code Enforcement/Community Planning and Development; Shirlie Stuart, Senior Municipal Consultant, and Cynthia Tulowiecki, Town Clerk.

#### PLEDGE OF ALLEGIENCE

Supervisor Bush called the town board meeting to order at 7:32 p.m. asked for the Pledge of Allegiance and pointed out the emergency exits.

#### DISCUSSIONS

Supervisor Bush asked if anyone in the audience had anything to discuss.

Dave Bardoun, the builder for American Homes, introduced himself and the owners, Rich and Frank. He requested to have a Public Hearing prior to next month's Town Board Meeting to get approval for a Site Plan Special Use Permit.

He has tried to negotiate with the owner, Carmen, many times but it only leads to empty promises. At present, the town's hands are tied. Supervisor Bush stated the clearing of the 5 acres of land on Barker Road is on hold for the time being. The board has looked over the plan and would like to make some changes.

The Town of Hastings Justices are specifically covered under the blanket bond, pursuant to Public Officers Law Section 11 (2) as provided to the Town of Hastings by Eastern Shores Associates Insurance Company.
